**Please check your temperature before going to campus. Then, review the questions below and respond accordingly.**

Do you have any new or worsening respiratory symptoms, such as cough, shortness of breath or sore throat?</li> <li>4. Have you had any new headache?</li> <li>5. Have you had a loss of smell or taste?</li> <li>6. Have you been in close contact* with anyone diagnosed with or with symptoms of coronavirus/COVID-19?</li> <li>7. Have you tested positive for COVID-19 or are you awaiting results from a COVID-19 test?</li> </ol>	<p><b>a)</b> Do not come to campus. If you are already on campus in your residence hall, stay there.</p> <p><b>b)</b> If you are on campus, <b>immediately</b> go home or back to your residence hall room.</p> <p><b>c) Employees:</b></p> <ol style="list-style-type: none"> <li>1) Contact your healthcare provider by phone for guidance.</li> <li>2) Inform your supervisor.</li> <li>3) <u>Complete the EGSC Self-Reporting form found at the top of the EGSC website.</u></li> </ol> <p><b>d) Students:</b></p> <ol style="list-style-type: none"> <li>1) Contact the student health services on the campus you attend <u>by phone</u> if you are in need of health services.</li> <li>2) Inform your faculty.</li> <li>3) If you live in the residence hall, inform the Director.</li> <li>4) <u>Complete the EGSC Self-Reporting form found at the top of the EGSC website.</u></li> </ol> <p><b>e) All:</b> Do not return to campus until you receive clearance from the EGSC COVID-19 Response Team.</p>	<p>You may go to campus</p>

\*Close contact is defined as someone who was within 6 feet of an infected person **for a cumulative total of 15 minutes or more over a 24-hour period\*** starting from 2 days before illness onset (or, for asymptomatic persons, 2 days prior to test specimen collection) until the time the person is isolated.

Per CDC, “\* Individual exposures added together over a 24-hour period (e.g., three 5-minute exposures for a total of 15 minutes). Data are limited, making it difficult to precisely define “close contact;” however, 15 cumulative minutes of exposure at a distance of 6 feet or less can be used as an operational definition for contact investigation.” See <https://www.cdc.gov/coronavirus/2019-ncov/php/contact-tracing/contact-tracing-plan/appendix.html#Key-Terms>

**REMINDER:** Follow physical distancing and other hygiene guidelines:

- a) Maintain at least 6 feet apart at all times
- b) You must wear an appropriate face covering while inside campus facilities/buildings. Face covering use will be in addition to and is **not** a substitute for social distancing. Face coverings are not required in one’s own dorm room or suite, when alone in an enclosed office or study room, or in campus outdoor settings where social distancing requirements are met. Anyone not using a face covering when required will be asked to wear one or must leave the area. Repeated refusal to comply with the requirement may result in discipline through the applicable conduct code for faculty, staff or students.
- c) Use frequent hand hygiene
- d) Clean workspaces and/or equipment throughout the day (for staff/employees, also at the end of the day)
- e) Most meetings should be held via conference call or Zoom. Faculty should maintain virtual office hours. Faculty may meet with students face-to-face in a large indoor space or outdoors. If meeting indoors, ensure social distancing is followed and all parties are wearing face coverings. If unable to maintain safe social distancing outdoors, a face covering must be worn, as well. No meetings will occur in faculty offices or hallways.
